BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3, Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 11-H in an area bound by

The public alley next north of and parallel to West Wilson Avenue; a line 135 feet west of and parallel to North Leavitt Street; West Wilson Avenue; And a line 165 feet west of and parallel to North Leavitt Street.

to those of a RT-4, Residential Two-Flat, Townhouse and Multi-Unit District.

SECTION 2. This ordinance takes effect after its passage and due publication.


