BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:


SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the C1-1 Neighborhood Commercial District symbols and indications as shown on Map No. 10-H in the area bounded by

a line 148 feet south of and parallel to West 46th Street; South Marshfield Avenue; a line 268 feet south of and parallel to West 46th Street; and the alley next west of and parallel to South Marshfield Avenue.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

This is an existing building with approximately 13K sq ft. of commercial space. There are 2 existing dwelling units above the 4618-20 address. There is an existing auto repair business that will remain and occupies approximately 9.5K sq ft. of the commercial space. The proposed Cannabis Craft Grower business will occupy approximately 3.5K sq ft. of commercial space from a current vacant space at the 4618 address. We are proposing zoning amendment for 4614-24 address range for possible future Cannabis business expansion. For the proposed 3.5K sq ft. of new use, no additional parking spaces will be provided.


