# <u>ORDINANCE</u>

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1.** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the B3-2 Community Shopping District and RT4 Residential Two-Flat, Townhouse and Multi-Unit District symbols and indications as shown on Map No.17-H in the area bounded by

West Touhy Avenue; a line 203.31 feet east of North Western Avenue as measured at the south right-of-way of West Touhy Avenue and perpandicular there to; the alley next north of and parallel to West Estes Avenue; the east right-of-way line of the alley next east of and parallel to North Western Avenue or the line thereof if extended where no alley exists; a line 185.96 feet south of West Touhy Avenue as measured at the east right-of-way line of North Western Avenue and perpendicular thereto; and North Western Avenue,

to those of a B3-2 Community Shopping District.

**SECTION 2.** This ordinance shall be in force and effect from and after its passage and due publication.


