#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1.** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the **M1-1**, **Limited Manufacturing/Business Park District** symbols and indications as shown on Map No. 2-K in the area bounded by

The alley next north of and parallel to West Taylor Street; a line 125.30 feet east of and parallel to South Keeler Avenue; West Taylor Street; and South Keeler Avenue

to those of an M2-1, Light Industry District.

**SECTION 2.** This ordinance shall be in force and effect from and after its passage and due publication.



In accordance with Section 17-13-0107 of the Chicago Zoning Ordinance, please be informed that on or about May 13, 2020, the undersigned will file an application for a change in zoning from a M1-1, Limited Manufacturing/Business Park District to an M2-1, Light Industry District District on behalf of MJA Chicago, LLC (the "Applicant") for the property located at 917-927 South Keeler Avenue, Chicago, IL 60624 (the "Subject Property").

The Applicant is seeking a zoning amendment for the Subject Property to establish a cannabis craft grower facility with accessory office space within the existing 2 story 14,200 square foot building that will provide cannabis to State of Illinois licensed medical and recreational dispensaries and infusing organizations.
