ORDINANCE PROSECCO Acct. No. 316198 - 2 Permit No. 1144566

Be It Ordained by the City Council of the City of Chicago:

Permission and authority are hereby given and granted to PROSECCO upon the terms and subject to the conditions of this ordinance, to maintain and use a portion of the public right of way for a sidewalk cafe adjacent to its premises located at 710 N. Wells St.. Said sidewalk cafe area #1 shall be forty (40) feet in length and nine (9) feet in width for a total of three hundred sixty (360) square feet and shall allow six (6) feet of clear space from the face of the curb/building line along N. Wells Street. The compensation for said space and the days and hours of operation for the sidewalk cafe shall be as follows:

Monday through Saturday 11:30 a.m. to 11:00 p.m. Compensation: \$828.00 SEATING CAPACITY: 30

#### Sidewalk Cafe Permit and approved plan must be posted at all times:

This grant of privilege #1144566 for a sidewalk cafe shall be subject to the provisions of Section 10-28-800 though 10-28-885 of the Municipal Code of Chicago and the directions of the Commissioner of Department of Business Affairs and Consumer Protection, the Commissioner of Streets and Sanitation, and the Commissioner of Transportation.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority for the above named privilege is herein given and granted from and after March 01, 2020 through and including February 28, 2021.

If BACP determines that your Application is complete accurate and in compliance with all pertinent provisions of the Municipal Code of Chicago and other applicable law BACP will prepare and submit an ordinance to the City Council recommending approval of the Application. You may also contact BACP at the address identified below if you wish to consider preparing and submitting on your own behalf an ordinance to the City Council that does not include an aldermanic recommendation. Such an ordinance will be subject to review for all applicable legal requirements.
