a line 65.00 feet north of and parallel to West Randolph Street; a line 100.20 feet east of and parallel to North Carpenter Street; West Randolph Street; North Carpenter Street;

to those of the DX-5 Downtown Mixed-Use District and a corresponding use district is hereby established in the area above described.

SECTION 2: This Ordinance shall be in force and effect from and after its passage and due publication.




