#### <u>ORDINANCE</u>

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the RS-3 Residential Single-Unit (Detached House) District and B1-2 Neighborhood Shopping District symbols and indications as shown on Map No.9-H in the area bounded by

a line 225 feet north of and parallel to West Roscoe Avenue; the alley next east of and parallel to North Paulina Street; a line 175 feet north of and parallel to West Roscoe Street; and North Paulina Street,

to those of a B2-3 Neighborhood Mixed-Use District.

**SECTION 2.** This ordinance shall be in force and effect from and after its passage and due publication.


The Applicant is seeking a Zoning Map Amendment in order to permit the construction of a new four-story multi-unit residential building, with attached garage, at the subject property, which such site is split-zoned. To accommodate for the new development, the Applicant intends to raze the existing non-conforming structures, which presently occupy the site. The proposed new four-story building will contain a total of fourteen (14) dwelling units, located on and between the 1st thru 4th Floors. The 1st Floor will also feature a residential lobby. Because the subject property is located within 1,320 linear feet of the entrance to the Paulina CTA Rail Station, it qualifies as a Transit-Served Location, pursuant to the current Zoning Ordinance. [Sec. 17-10-0102-B] As such, the Applicant will be providing off-street parking for a total of four (4) vehicles – a 75% reduction, which such parking will be located in an attached garage, at the rear of the 1st Floor. The proposed new building will be masonry in construction and will measure 48 feet–0 inches in height.



















FRONT ELEVATION




