Grant(s) of privilege in public way for Ogden North LLC occupation of space - 1256 -- 1260 S Washtenaw Ave Committee on Transportation and Public Way ORDINANCE Ogden North LLC Acct. No. 350716 - 1 Permit No. 1145937

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to Ogden North LLC, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Occupation of Space(s) on the public right-of-way adjacent to its premises known as 1256-1260 S. Washtenaw Ave..

Said Occupation of Space(s) at 1256-1260 S. WASHTENAW measure(s): One (1) at fifty point zero five (50.05) feet in length, and five point five (5.5) feet in width for a total of two hundred seventy-five point two eight (275.28) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development, Department of Transportation (Division of Project Development), and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.


The grantee shall pay to the City of Chicago as compensation for the privilege #1145937 herein granted the sum of four hundred (\$400.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after 05/12/2020.
