# <u>ORDINANCE</u>

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1.** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No 3-I in the area bounded by

The alley next north of and parallel to West Evergreen Avenue; a line 345 feet west of and parallel to North Rockwell Street; West Evergreen Avenue; and a line 370 feet west of and parallel to North Rockwell Street,

to those of a RT4 Residential Two-Flat, Townhouse and Multi-Unit District.

**SECTION 2.** This ordinance shall be in force and effect from and after its passage and due publication.


