BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

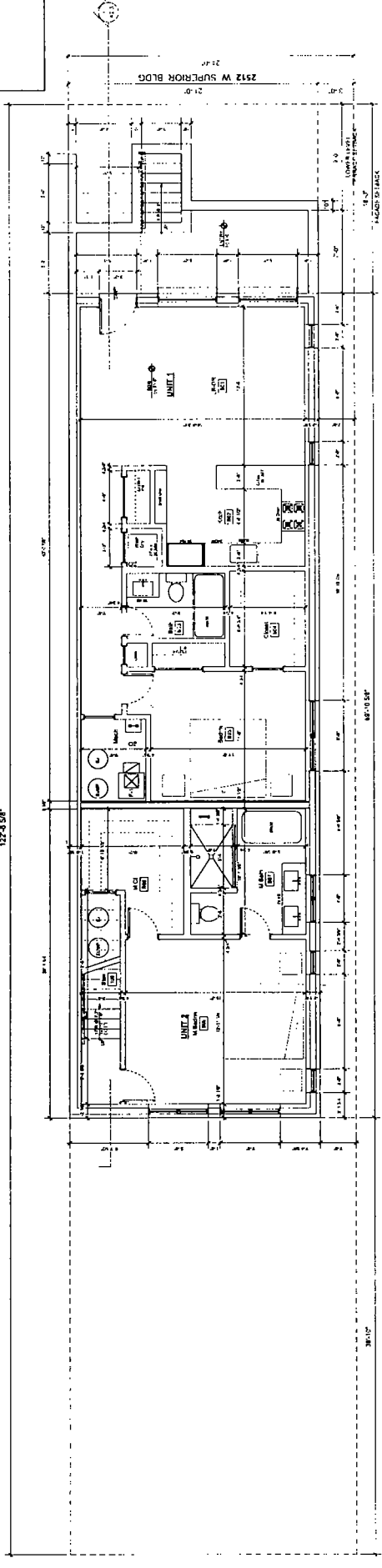
SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing the RS-3, Residential Single-Unit Detached House District designation as shown on Map Number 1-I in the area bounded by:

The alley next north and parallel to West Superior Street; a line 122 feet west of and parallel to North Campbell Avenue; West Superior Street; and a line 146 feet west of and parallel to North Campbell Avenue

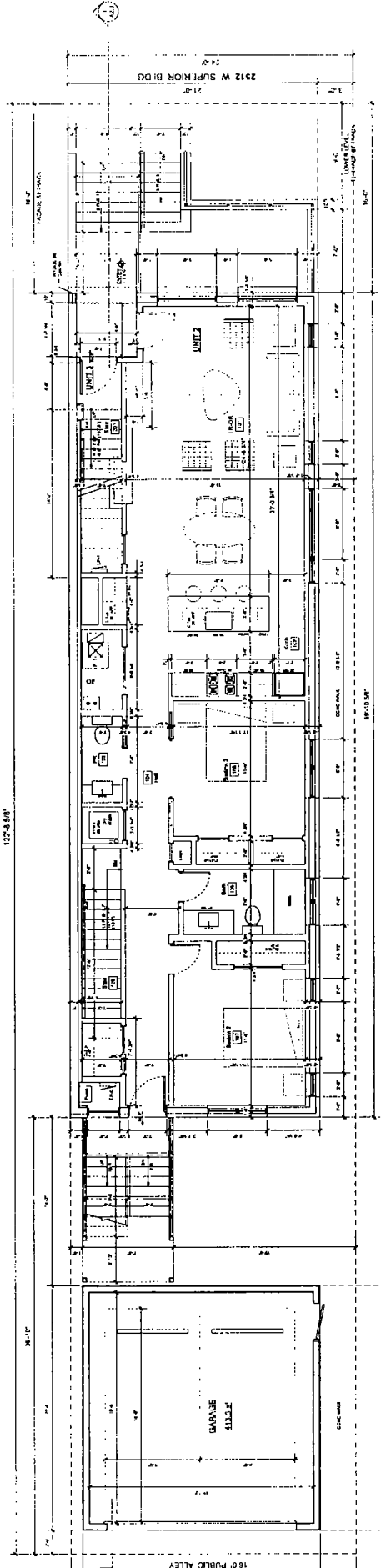
to those of a B2-3, Neighborhood Mixed-Use District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

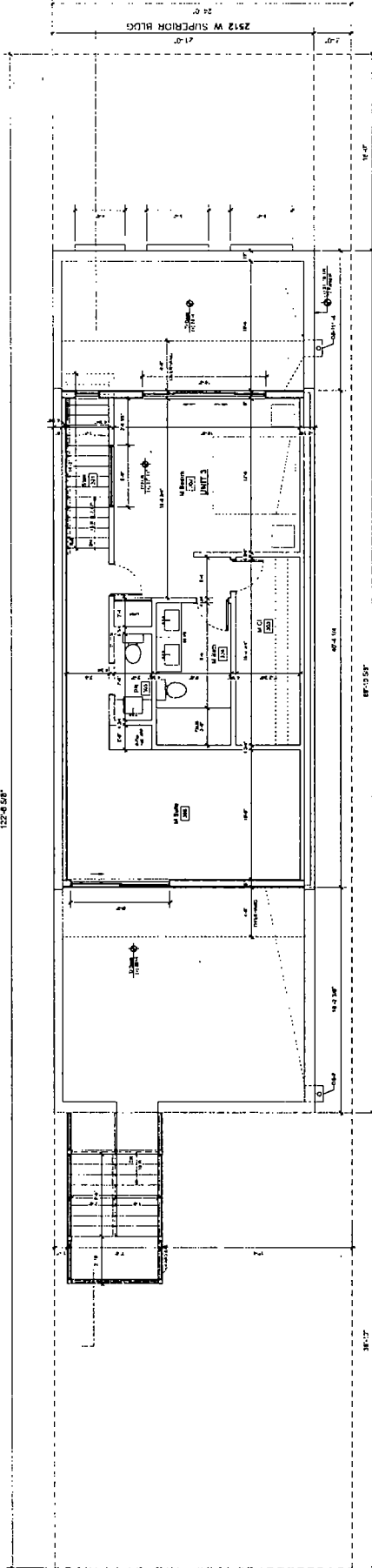
