ORDINANCE

BE IT ORDAINED BT THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. That the Chicago Zoning Ordinance be amended by changing all of the **B1-1**, **Neighborhood Shopping District** symbols and indications as shown on Map 7-J in the area bounded by:

A line 75 feet northwesterly of and parallel to North Davlin Court; North Milwaukee Avenue; North Davlin Court; the alley next southwesterly of and parallell to North Milwaukee Avenue

To those of a C2-2, Motor Vehicle-Related Commercial District.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and publication.



In accordance with Section 17-13-0107 of the Chicago Zoning Ordinance, please be informed that on or about September 2, 2020, the undersigned will file an application for a change in zoning from a B1-1, Neighborhood Shopping District to a C2-2, Motor Vehicle-Related Commercial District on behalf of 3172 North Milwaukee, LLC (the "Applicant") for the property located at 3170-74 North Milwaukee Ave., Chicago, IL 60618 (the "Subject Property").

The Applicant is seeking a zoning amendment for the Subject Property to allow for a broader range of commercial type uses. The existing 1-story building will remain. No changes to it are planned. The existing multiple white-box tenant spaces are provided for tenants looking to establish uses allowed under the commercial and industrial use groups. 4 existing parking spaces are provided.
