<u>ORDINANCE</u>

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code, the Chicago Zoning Ordinance, be amended by changing all the C1-2 Neighborhood Commercial District symbols and indications as shown on Map No. 9-F in the area bounded by

a line 93.68 feet north of and parallel to West Buckingham Place; the Alley next east of and parallel to North Halsted Street; a line 66.68 feet north of and parallel to West Buckingham Place; and North Halsted Street;

to those of a C1-3 Neighborhood Commercial District is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
