#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance

be amended by changing all the RS3 Residential Single-Unit (Detached House) District

symbols and indications as shown on Map No. 3-G in the area bounded by

a line 92.70 feet north of and parallel to West Blackhawk Street; a line 31.25 feet west of and parallel to North Cleaver Street; West Blackhawk Street; and a line 62.50 feet west of and parallel to North Cleaver Street,

to those of a B2-3 Neighborhood Mixed-Use District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.


- The Applicant is seeking a Zoning Map Amendment in order to permit the Proposed Land Use: reestablishment of a *commercial use* (restaurant-café), within the 1<sup>st</sup> Floor of the existing mixed-use building, and to bring any non-conforming conditions into compliance under the current Zoning Ordinance. The subject property is presently improved with a four-story mixed-use building, with a single commercial unit - at grade level, and eight (8) dwelling units – above (2<sup>nd</sup> thru 4<sup>th</sup> Floors). The commercial unit has been vacant for over a year. Aside from the interior buildout of the existing gradelevel unit, to allow for the proposed new commercial operations (i.e. café), as well as certain interior renovations to the eight (8) existing dwelling units. the Applicant will not be expanding the footprint or envelope of the building. Because the existing building spans the entirety of the site, there is no off-street accessory parking. \*[The subject property qualifies as a Transit Served Location, under the current Zoning Ordinance, since it is located within 1,320 linear feet of the Ashland Avenue Bus Corridor. As such, the Applicant is seeking to eliminate the required off-street parking.] The existing building is masonry in construction and measures 46 feet-10 inches in height.
