Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, Is hereby amended by changing all of the C1-1 Neighborhood Commercial District symbols and indications as shown on Map Number 5-k in the area bounded by:

West Armitage Avenue: North Kenneth Avenue: a public alley next south of and parallel to West Armitage Avenue, and a line 49.5 feet west of and parallel to North Kenneth Avenue,

to those of a C1-1 Neighborhood Commercial District

Section 2 This ordinance takes effect after its passage and approval.
