#### **ORDINANCE**

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO.

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the current C1-2 Neighborhood Commercial District symbols and indications as shown on Map No. 9-G in the area bounded by:

a line 279.30 feet north of and parallel to West Roscoe Avenue; the public alley next cast of and parallel to North Ashland Avenue; a line 124.30 feet north of and parallel to West Roscoe Avenue; North Ashland Avenue

to those of a B3-2 Community Shopping District.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.
