ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code, the Chicago Zoning Ordinance, be amended by changing all the B1-2 Neighborhood Shopping District symbols and indications as shown on Map No. 9-H in the area bounded by

A line 196 feet south of and parallel to West Roscoe Street; North Marshfield Avenue; a line 246 feet south of and parallel to West Roscoe Street; a line 306.5 feet southeast of and parallel to North Lincoln Avenue as measured from the intersection at West Roscoe Street and North Lincoln Avenue; North Lincoln Avenue; and a line 256.5 feet southeast of and parallel to North Lincoln Avenue as measured from the south intersection at West Roscoe Street and North Lincoln Avenue

to those of a B1-3 Neighborhood Shopping District is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.


TYPE 1 ZONING ANALYSIS

The applicant is seeking to rezone the subject property from its existing B1-2 classification to a B1-3 classification to: (a) increase the maximum floor area ratio for the proposed addition; and (b) to reduce the minimum off-street automobile parking ratio by 100 percent as a transit served location. Following is the additional information regarding the proposed development required for the subject application:


- a. lot area = 6,234 sq. ft.
- b. floor area ratio = 2.75
- c. building area = 17,140.69 sq. ft.
- d. density (lot area per dwelling unit) = 779.25 sq. ft.
- e. off-street parking = 0 spaces*
- f. setbacks:
 - i. side-north setback = proposed 0
 - ii. rear-east setback = proposed 0*
 - iii. side-south setback = proposed 0
 - iv. front-west setback = 0 ft (existing)
- g. building height = 41'-1" (existing)




PROPOSED BASE LEVEL FOUNDATION PLAN


PROPOSED 0TH FLOOR PLAN




