#### **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1.** Title 17 of the Municipal Code, the Chicago Zoning Ordinance, be amended by changing all the B1-2 Neighborhood Shopping District symbols and indications as shown on Map No. 9-H in the area bounded by

A line 196 feet south of and parallel to West Roscoe Street; North Marshfield Avenue; a line 246 feet south of and parallel to West Roscoe Street; a line 306.5 feet southeast of and parallel to North Lincoln Avenue as measured from the intersection at West Roscoe Street and North Lincoln Avenue; North Lincoln Avenue; and a line 256.5 feet southeast of and parallel to North Lincoln Avenue as measured from the south intersection at West Roscoe Street and North Lincoln Avenue as measured from the south intersection at West Roscoe Street and North Lincoln Avenue

to those of a B1-3 Neighborhood Shopping District is hereby established in the area above described.

**SECTION 2.** This ordinance shall be in force and effect from and after its passage and due publication.




The applicant is seeking to rezone the subject property from its existing B1-2 classification to a B1-3 classification to: (a) increase the maximum floor area ratio for the proposed addition; and (b) to reduce the minimum off-street automobile parking ratio by 100 percent as a transit served location. In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about September 30, 2020, the undersigned will file an application for a change in zoning from B1-2 to B1-3 on behalf of Chicago 3333 Lincoln LLC, an Illinois limited liability company (the "Applicant") for the property located at 3333-35 N.
