BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all B1-2 Neighborhood Shopping District symbols and indications as shown on Map No. 7-F in the area bounded by


West Wrightwood Avenue; North Burling Street; a line 58 feet south of and parallel to West Wrightwood Avenue; a line 48 feet west of and parallel to North Burling Street

to those of a B1-3 Neighborhood Shopping District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

In accordance with the Amendment to the Zoning Code enacted by the City Council, Section 17-13-0107-A of the Chicago Zoning Ordinance, please be advised that on or about December 16, 2020, the undersigned, will file an application for a change in zoning for the property located at 735-37 West Wrightwood Avenue from a B1-2 Neighborhood Shopping District to a B1-3 Neighborhood Shopping District.

The purpose of the rezoning is to comply with bulk, density, and minimum lot area requirements to allow for the construction of a 2-story addition and 2 dwelling units on the west side of the existing 3 story mixed use building. The proposed addition and dwelling units will be located above the existing west side ground floor commercial unit. After rezoning, there will be a total of 2 ground floor commercial units and 4 dwelling units. The height of the existing building will remain unchanged. There is no existing parking and 2 parking spaces will be provided off-site located at 725 W. Wrightwood.
