ORDINANCE

WHEREAS, the City of Chicago (the "City") is a home rule unit of government by virtue of the provisions of the Constitution of the State of Illinois of 1970, and as such, may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the City's Department of Planning and Development ("<u>DPD</u>") previously has issued a Request for Qualifications ("<u>RFQ</u>") for its Third Ward Parade of Homes Program (the "<u>Program</u>"), which is intended to stimulate the development of market-rate housing west of King Drive in the Grand Boulevard community; and

WHEREAS, DPD determined that the following five (5) developers which responded to the RFQ are qualified to participate in the Program: (i) R & D Builders LLC, an Illinois limited liability company, located at 3935 South Wells Street, #1, Chicago, Illinois; (ii) Click Development, LLC, an Illinois limited liability company, located at 427 East 48th Street, #2, Chicago, Illinois; (iii) Urban Equities, Inc., an Illinois corporation, located at 1016 West Jackson Boulevard, Chicago, Illinois; (iv) Wade Enterprise & Associates, Inc., an Illinois corporation, located at 3205 South Rhodes Avenue, Chicago, Illinois; and (v) Greenline Development, Inc., an Illinois corporation, located at 6625 South Ingleside Avenue, Chicago, Illinois (each, a "Developer," and, collectively, "Developers"); and

WHEREAS, Urban Equities, Inc., no longer participates in the Program; and

WHEREAS, pursuant to an ordinance ("Ordinance") adopted by the City Council on March 29, 2017, and published at pages 44637 through 44678 in the Journal of the Proceedings of the City Council for such date (the "Journal"), the City has entered into an Agreement for the Sale and Redevelopment of Land with each Developer, other than Urban Equities, Inc. (each, a "Redevelopment Agreement," and, collectively, the "Redevelopment Agreements"), relating to the properties identified in Exhibit A of the Ordinance, as such Exhibit A was as amended pursuant to ordinance adopted by the City Council on July 25, 2018, and published at pages 82239 through 82243 in the Journal for such date (each of the properties identified in such Exhibit A, as amended, individually, a "Parcel," and, collectively, the "Parcels"); and

WHEREAS, the City's Department of Assets, Information and Services has determined that several of the Parcels require environmental testing and/or environmental remediation; and

WHEREAS, the cost of such environmental testing and remediation, in excess of the cost of environmental testing and environmental remediation already required by the Redevelopment Agreements, was not considered when the Parcels were appraised or contemplated at the time the Redevelopment Agreements were executed; and

WHEREAS, the City's Department of Housing ("DOH") currently administers the Program; and

WHEREAS, in order to further the purposes of the Program, the Developers have requested, and the City has agreed, that some or all of the purchase price for each Parcel purchased by a

Developer should be deposited in an environmental escrow, and such escrowed funds may be used to reimburse the Developer for certain environmental testing and environmental remediation costs approved by the City and incurred in relation to the Parcel for which the Developer paid the "Purchase Price" (as that term is defined in the Ordinance) and for subsequent Parcels acquired by the Developer; now therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The foregoing recitals are hereby adopted as the findings of the City Council.

SECTION 2. The Commissioner of DOH, or any successor department thereto ("Commissioner"), or a designee of the Commissioner, is each hereby authorized, with the approval of the City's Corporation Counsel as to form and legality, to negotiate, execute and deliver an amendment to each of the Redevelopment Agreements, for the purpose of permitting some or all of the Purchase Price for each Parcel to be deposited into an escrow account and used for environmental testing and/or environmental remediation costs approved by the City for such Parcel or any other Parcel(s) conveyed by the City to a Developer after this ordinance becomes effective, and such other supporting documents, including escrow agreements, as may be necessary or appropriate to carry out and comply with the provisions of each amendment to the Redevelopment Agreements. The dollar amount of the Purchase Price for each Parcel to be deposited into the escrow accounts and the Parcel(s) for which such escrowed funds may be used for environmental testing and/or environmental remediation costs shall be in the sole discretion of the Commissioner.

<u>SECTION 3</u>. If any provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such provision shall not affect any of the other provisions of this ordinance.

SECTION 4. All ordinances, resolutions, motions or orders in conflict with this ordinance are hereby repealed to the extent of such conflict.

SECTION 5. This ordinance shall take effect immediately upon its passage and approval.
