THE COMMITTEE CONSIDERED TWO ITEMS WHICH RECEIVED DO NOT PASS RECOMMENDATIONS.

THE FIRST WAS DOCUMENT NO. 02019-3815. THE HISTORICAL LANDMARK DESIGNATION FOR THE PILSEN HISTORIC DISTRICT, PRIMARILY W 18TH STREET FROM S LEAVITT ST TO S SANGAMON ST, AND RESIDENTIAL BLOCKS BOUNDED BY W 18TH ST, S ASHLAND AVE, W 21ST ST AND S RACINE AVE. THIS ORDINANCE RECEIVED A DO NOT PASS RECOMMENDATION FROM THE COMMITTEE BY A ROLL CALL VOTE OF <u>0 (ZERO) YEAS AND</u> <u>18 (EIGHTEEN) NAYS</u>

THE SECOND ITEM WAS DOCUMENT NO. 02020-4530, A CALL FOR A TEMPORARY MORATORIUM ON THE ISSUANCE OF COMPLETE DEMOLITION PERMITS FOR APPLICATIONS FILED ON OR AFTER NOVEMBER 1, 2020 WITHIN PILSEN HISTORIC DISTRICT. THIS ORDINANCE RECEIVED A DO NOT PASS RECOMMENDATION FROM THE COMMITTEE BY A ROLL CALL VOTE OF <u>7 (SEVEN) YEAS AND 11 (ELEVEN) NAYS.</u>
