#20597 INTRO DATE JAN 27, 2021

#### **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1**: Title 17 of the Municipal Code of Chicago, Chicago Zoning Ordinance, is amended by changing all the DX-3 Downtown Mixed-Use District and DS-3 Downtown Service District and symbols and indications as shown on Map No. 2-G in the area bounded by:

The south line of vacated West Arcade Place; A line 337.39 feet east of and parallel to South Racine Avenue; West Monroe Street; A line 142.74 feet east of and parallel to South Racine Avenue

to those of DS-5 Downtown Service District, which is hereby established in the area above described.

**SECTION 2**: This ordinance shall take effect upon its passage and due publication.


