South Kildare Avenue,

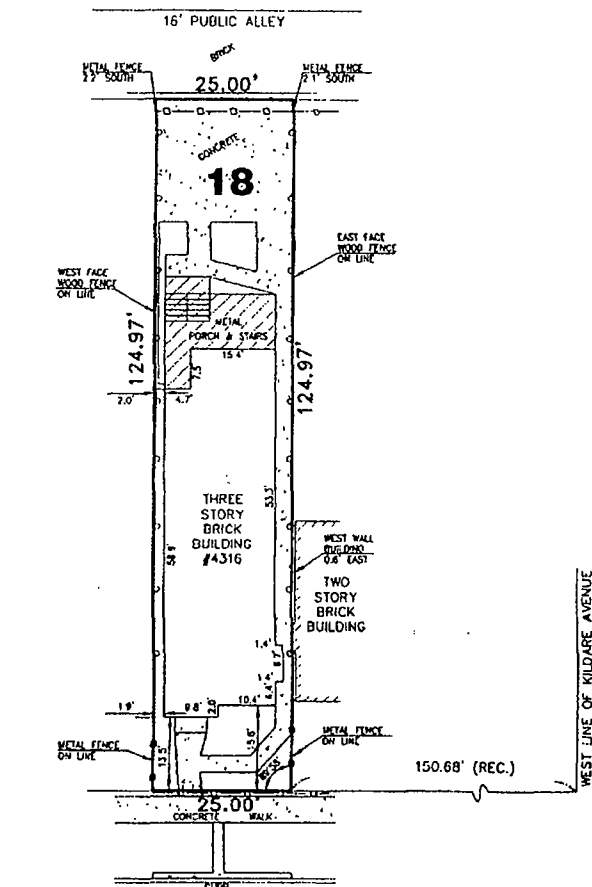
to those of an RM-4.5 Residential Multi-Unit District and a corresponding uses district.
