BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Residential Single Unit (Detached House) District symbols and indications as shown on Map No. 15-I in an area bound by


A line 186.6 feet south of and parallel to West Hollywood Avenue; the public alley next east of and parallel to North Artesian Avenue; a line 216.6 feet south of and parallel to West Hollywood Avenue; North Artesian Avenue


