Be It Ordsined by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granited to KING SWEETS, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Awning(s) projecting over the public right of way adjacent to its premises known as 2308 W. Devon Ave...

Said Awning(s) at W. DEVON AVE. measure(s): One (1) at twenty-five (25) feet in length, and three (3) feet in width, for a total of seventy-five (75) square feet.

The location of said privilage shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department -Signs

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall psy to the City of Chicago as compensation for the phylicge #1147942 herein granted the sum of fifty (\$50.00) per annum in advance.

A 25% penalty will be added for payments received after due date.


