### Biography

The children of Guadalupe Lopez, a beloved 911 dispatcher who died from complications of COVID-19 on November 2020, had a videographer follow them around at their father's funeral so they could show their mother and his wife, Maria Lopez, who was hospitalized with the coronavirus. But Maria Lopez never got to see the video about how her husband received full honors from the Chicago Police Department. Maria Lopez, 56, died from complications of COVID-19 at Loyola University Medical Center in Maywood.

#### **Reason for Honoring**

Within two weeks of falling ill, both Guadalupe and Maria Lopez were admitted to MacNeal Hospital in Berwyn. Both succumbed to complications of COVID-19. Mr. Guadalupe Lopez served the City of Chicago with honor as a 911 dispatcher and was given full honors from the Chicago Police Department. Just like her husband, Mrs. Maria Lopez's mission in life was to help and service her community. She owned and operated a tax business in Little Village, where she was born and raised.


