The alley next north of and parallel to West Armitage Avenue; a line 159.34 feet east of and parallel to North Harlem Avenue; West Armitage Avenue; and North Harlem Avenue,

to those of a B3-1 Community Shopping District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
