# #20663-TI INTRO DATE MARCH 24, 2021

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1.** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the C1-1 Neighborhood Commercial District, as shown on Map 7-G in the area bounded by:

A line 74.76 feet West of and parallel to North Wayne Street; West Wrightwood Avenue; a line 99.76 feet West of and parallel to North Wayne Street; and the alley next South of and parallel to West Wrightwood Avenue.

To those of **RM-5 Residential Multi-Unit District** 

**SECTION 2.** This ordinance shall be in force and effect from and after its passage and due publication.

#### NARRATIVE AND PLANS FOR THE PROPOSED REZONING AT 1341 WEST WRIGHTWOOD AVENUE

The Application is to change zoning for 1341 West Wrightwood Avenue from C1-1 Neighborhood Commercial District to RM-5 Residential Multi-Unit District. The Applicant intends to construct a three (3) dwelling unit building with partial fourth floor and a basement. There will be three garage parking spaces. The footprint of the building shall approximately be 20 feet by 80 feet in size. The building height shall be 45 feet, as defined by City code.
