ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1 Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of RS-2 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 16-H in the area bounded by:

The public alley next North of and parallel to West 69th Street; a line 99 feet West of and parallel to South Damen Avenue; West 69th Street; and a line 149 feet West of and parallel to South Damen Avenue

to those of a B3-1 Community Shopping District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.


