ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1 Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of B1-1 neighborhood shopping District symbols and indications as shown on Map No. 26-F in the area bounded by:

West 103rd Street; South State Street; the public alley next South and parallel to West 103rd Street; and a line 159.11 feet West of and parallel to South State Street

to those of a C2-1 Motor Vehicle-Related Commercial District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.


