### **ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the C1-2 Neighborhood Commercial District symbols and indications as shown on Map No. 4-J in an area bound by

The public alley next north of and parallel to West Cermak Avenue; South Sawyer Avenue; West Cermak Avenue; And a line 145.0 feet west of and parallel to South Sawyer Avenue

to those of a B3-3 Community Shopping District.

SECTION 2. This ordinance takes effect after its passage and due publication.





3232-46 W CERMAK RD CHICAGO,IL 80623 A-1 SITE PLAN
