#### **ORDINANCE**

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1.** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RT-3.5 Residential Two-Flat, Townhouse and Multi-Unit District, as shown on Map 9-G in the area bounded by:

A line 187 feet North of and parallel to West Belmont Avenue; the alley next east of and parallel to North Southport Avenue; a line 162 feet North of and parallel to West Belmont Avenue; and North Southport Avenue.

To those of RM-4.5 Residential Multi-Unit District

**SECTION 2.** This ordinance shall be in force and effect from and after its passage and due publication.

# NARRATIVE AND PLANS FOR THE PROPOSED REZONING AT 3217 NORTH SOUTHPORT AVENUE

The Application is to change zoning for 3217 North Southport Avenue from RT-3.5 Residential Two-Flat, Townhouse and Multi-Unit District to RM-4.5 Residential Multi-Unit District. The Applicant intends to construct a three (3) dwelling unit building with a basement and partial fourth floor. There will be three garage parking spaces. The footprint of the building shall approximately be 19 feet 8 inches by 71 feet 10 inches in size. The building height shall be 45 feet high, as defined by City code.




SIFOURTH FLOOR PLAN


