Be It Ordained by the City Council of the City of Chicago?

SECTION 1. Permission and authority are hereby given and granted to RMW STREETERVILLE LLC upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use three (3) Cornice(s) projecting over the public right-of-way adjacent to its premises known as 451 E GRAND AVE.

Said Cornice(s) at N. Peshtigo Court measure(s):

One (1) at one hundred ninety-six point nine two (196.92) feet in length and one (1) feet in width for a total of one hundred ninety-six point nine two (196.92) square feet.

Said Cornice(s) at E. Grand Avenue measure(s):

One (1) at one hundred thirty-one point three three (131.33) feet in length and one (1) feet in width for a total of one hundred thirty-one point three three (131.33) square feet.

One (1) at fifty-one point six seven (51.67) feet in length and one (1) feet in width for a total of fifty-one point six seven (51.67) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #BACP1533276 herein granted the sum of one thousand two hundred (\$1,200.00) per annum in advance.

A 25% penalty will be added for payments received after due date.


