ORDINANCE MONTEVERDE Acct. No.: 392794 - 1 Permit No: BACP1535368

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to MONTEVERDE upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use four (4) Awning without Lettering or Graphics(s) projecting over the public right-of-way adjacent to its premises known as 1020 W MADISON ST.

Said Awning without Lettering or Graphics(s) at W. Madison Street measure(s): One (1) at nine point seven five (9.75) feet in length and four (4) feet in width for a total of thirty-nine (39) square feet.

Said Awning without Lettering or Graphics(s) at N. Carpenter Street measure(s): One (1) at nine point seven five (9.75) feet in length and four (4) feet in width for a total of thirty-nine (39) square feet.

Said Awning without Lettering or Graphics(s) at W Madison Street measure(s): One (1) at thirty-two point eight three (32.83) feet in length and eight point five (8.5) feet in width for a total of two hundred seventy-nine point zero six (279.06) square feet.

Said Awning without Lettering or Graphics(s) at N Carpenter Street measure(s): One (1) at thirty-four point seven five (34.75) feet in length and eight point five (8.5) feet in width for a total of two hundred ninety-five point three eight (295.38) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #BACP1535368 herein granted the sum of two hundred seventeen point five eight (\$217.58) per annum in advance.

A 25% penalty will be added for payments received after due date.


