#### <u>ORDINANCE</u>

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1.** Title 17 of the Municipal Code, the Chicago Zoning Ordinance, be amended by changing all the C1-1 Neighborhood Commercial District symbols and indications as shown on Map No. 11-K in the area bounded by

West Lawrence Avenue; North Knox Avenue; the alley next south of and parallel to West Lawrence Avenue; a line 150 feet west of and parallel to North Knox Avenue

to those of a C2-1Motor Vehicle-Related Commercial District is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
