BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M2-1, Light Industry District symbols and indications as shown on Map No.3-J in the area bounded by

West Potomac Avenue; Chicago Milwaukee and St. Paul Rail Road Right-of-Way; West Division Street; and North Central Park Avenue

to those of a C2-1 Motor Vehicle-Related District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
