West Pershing Road; S. Normal Street; Chicago Junction Rail Yard; South Wallace Street

to those of a Planned Development District.


STREETSCAPE MAP (SITE #16)



NW PEDESTRIAN VIEW ELEVATION #16




PLANNED DEVELOPMENT BOUNDARY AND PROPERTY LINE MAP






EXISTING LAND USE MAP




