SECTION 1. That the Chicago Zoning Ordinance be amended by changing the DR-3 Downtown Residential District symbols and indications as shown on Map 3-E in the area bounded by:

A line 49 feet south of and parallel to East Cedar Street; a line 143 feet east of the intersection of North Rush Street and East Cedar Street as measured along the south line of East Cedar Street and perpendicular thereto; a line 73.5 feet south of and parallel to East Cedar Street; and a line 127 feet east of the intersection of North Rush Street and East Cedar Street as measured along the south line of East Cedar Street and perpendicular thereto; but here to be south line of East Cedar Street and perpendicular thereto.

to those of DX-7 Downtown District.

Dear Property Owner:

In accordance with the requirements of Section 17-13-0107 of the Municipal Code of the City of Chicago, please be informed that on or about June 23, 2021, the undersigned, on behalf of 1045-47 North Rush L.L.C., intends to file an application to rezone a small portion (384sf) of the property located at 1045-1047 North Rush Street.

A map of the subject property is printed on the reverse side of this letter. The affected portion is the area indicated by a small rectangle on the eastern portion (rear/alley side) of the subject property. The rezoning would update the zoning map to rezone the small portion on the eastern portion of the subject property from the DR-3 Downtown Residential District to a DX-7 Downtown Mixed-Use Zoning District, thus creating a single zoning lot as is required by the City. In our research and discussions with the appropriate city departments, there was no rationale for the rear 200sf to have been zoned differently than the main parcel.

<u>The development proposal remains unchanged from plans and elevations previously submitted to the</u> <u>City and Alderman Reilly</u>: the construction of a new 5-story building consisting of ground floor commercial, a three-story restaurant and one residential dwelling unit served by one parking space. A rendering that you may recognize from the Alderman's *Reilly Reports* is copied below the map for your reference.

The proposed application does *not* apply to your property. You are receiving this notice because Cook County tax records indicate that you own property within 250 feet (more or less) of the subject property.

1045-47 North Rush L.L.C. is the applicant and owner of the property and its address is 9440 Enterprise Drive, Mokena, IL 60480. I am an authorized representative of the Applicant and my address is 444 W. Lake Street, Suite 900, Chicago, Illinois 60606.




