ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RT-4 Residential Two-Flat, Townhouse and Multi-Unit District and C1-2 Neighborhood Commercial District symbols and indications as shown on Map Number 18-B in the area bounded by:

East 72nd Place; a line 33.60 feet northeast of and parallel to South Exchange Avenue; a line 100.25 feet northwest of and parallel to East 73rd Street; a line 115.70 feet northeast of South Exchange Avenue; East 73rd Street; and South Exchange Avenue

to those of a C1-2 Neighborhood Commercial District, and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

The existing one story building will remain unchanged (interior remodeling only)
