# ORDINANCE

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1.** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the B1-1 Neighborhood Shopping District symbols and indications as shown on Map No. 11-H in the area bounded by

the alley next north of and parallel to West Irving Park Road; a line 175.00 feet east of and parallel to North Hoyne Avenue; West Irving Park Road; and a line 112.50 feet east of and parallel to North Hoyne Avenue,

to those of a B2-3 Neighborhood Mixed-Use District.

**SECTION 2.** This ordinance shall be in force and effect from and after its passage and due publication.




Proposed Land Use: The subject property consists of two contiguous lots of record. The west parcel (Lot 52) is presently improved with a vacant two-and-half-story multi-unit residential building, while the east parcel (Lot 53) is presently vacant and unimproved. The existing improvements are non-conforming under the current Zoning Ordinance (B1-1). The Applicant is seeking a Zoning Map Amendment in order to raze the existing non-conforming structures and to redevelop the site, in its entirety, with a new four-story multi-unit residential building. The new proposed building will feature a total of twenty-two (22) dwelling units on and between the 1st thru 4th Floors, with parking for seven (7) vehicles located within the interior of the 1st Floor and surface parking for an additional six (6) vehicles at the rear of the site - for a total of thirteen (13) off-street vehicular parking spaces, which represents parking for over 60% of the dwelling units. The new proposed building will measure 46-feet in height and will be masonry in construction.


