Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to UPCORP upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use one (1) Planter(s) on the public right-of-way for beautification purposes adjacent to its premises known as 1329 W WILSON AVE.

Said Planter(s) at W WILSON AVE measure(s): One (1) at four (4) feet in length and Zero (0) feet in width for a total of four (4) square feet.

Grantee must allow the required clear and unobstructed space for pedestrian passage at all times per rules and regulations approved by the Department of Transportation.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

The grantee shall pay to the City of Chicago as compensation for the privilege #BACP1552968 herein granted the sum of Zero (\$0.00) per annum in advance.


A 25% penalty will be added for payments received after due date.
