Be it Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to Greater Ravenswood Chamber of Commerce upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use one (1) Sculpture(s) on the public right-of-way adjacent to its premises known as 4159 N RAVENSWOOD AVE.

Said Sculpture(s) at N Ravenswood Ave measure(s):

One (1) at seven (7) feet in length and three point five (3.5) feet in width, for a total of twenty-four point five (24.5) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk:

The grantee shall pay to the City of Chicago as compansation for the privilege #BACP1536531 herein granted the sum of Zero (\$0.00) per annum in advance;


A 25% perialty will be added for payments received after due date.
