THE PERFECT CUP INC

Be it Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to THE PERFECT CUP INC upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Parts bench(s) on the public right-of-way for beautification purposes adjacent to its premises known as 4700 N DAMEN AVE.

Sald Park bench(s) at N. Damen Ave. measure(s):

One (1) at eight (8) feet in length and Zero (0) feet in width, for a total of eight (8) square feet.

Said Park bench(s) at W. Leland Ave. measure(s):

One (1) at six (6) feet in length and Zero (0) feet in width, for a total of six (6) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clark.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #BACP1544017 herein granted the sum of one hundred fifty (\$150.00) per annum in advance.


A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after 07/28/2021.
