BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance,

is hereby amended by changing all the M1-1 Limited Manufacturing / Business Park

District symbols and indications as shown on Map No.15-N in the area bounded by

A line 100 feet southeast of the intersection of North Northwest Highway and North Ardmore Avenue as measured along the southwest right-ofway line of North Northwest Highway and perpendicular thereto; North Northwest Highway; a line 300 feet southeast of the intersection of North Northwest Highway and North Ardmore Avenue as measured along the southwest right-of-way line of line of North Northwest Highway and perpendicular thereto; and the northeasterly right-of-way line of the Chicago and North Western Railway

to those of a M2-1 Light Industry District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
