BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing the current zoning district RT-4 Residential Two Flat, Townhouse and Multi-Unit district, Map No. 16-E, in the area bounded by

A line 48.36 feet north of and parallel to east 67<sup>th</sup> street; a line 40.36 feet east of and parallel to south St. Lawrence Ave.; East 67<sup>th</sup> Street; and South St. Lawrence Avenue

to those of a B1 -1 Neighborhood Shopping District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
