ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all RS-3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 8-H in the area bounded by

West 38th Street; South Hermitage Avenue; the public alley south of and parallel to West 38th Street; a line 48 feet west of and parallel to South Hermitage Avenue

to those of a CI-1 Neighborhood Commercial District

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
