**West Chicago Avenue; a line 48 feet East of and parallel to North Elizabeth Street; a line 66.5 feet next South of and parallel to West Chicago Avenue; North Elizabeth Street.**

**To those of a B2-3, Neighborhood Mixed-Use District**
