### ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RM4.5, Residential, Multi-Unit District symbols and indications as shown on Map No. 8-G in the area bounded

West 36<sup>th</sup> Street; South Sangamon Street; a line 210.13 feet south of and parallel to West 36<sup>th</sup> Street; a line 206.17 feet west of and parallel to South Sangamon Street; a line 147.13 feet south of and parallel to West 36<sup>th</sup> Street; and a line 181.16 feet west of and parallel to South Sangamon to those of a RM4.5, Residential Multi-Unit District, as Amended.

Section 2. This ordinance takes effect after its passage and approval.
