The Department of Housing introduced, and City Council approved (July 24, 2019), an ordinance selling the aforementioned parcel to Ross Brothers Construction, LLC (02019-4164.) This ordinance was subsequently amended on October 6, 2019 (02019-7771.)

It had been known to the Department of Housing and to Alderman Burnett that the zoning would need to be changed from RT4 to RM4.5.

Just as the Department of Housing requested that the Building Department process a permit application while the City

retained ownership, we are asking that Zoning process the application for a zoning change from Ross Brothers Construction while the City remains the parcel owner.

The Department of Housing will not close on the sale of the land until a building permit has been issued, and the rezoning of the parcel must occur first.
