In each role, Patti has proven herself to be a dedicated and faithful employee who has contributed greatly to the efficiency of Chicago city government; and

WHEREAS, While Patti's presence will certainly be missed, her impact on the city's landscape will be felt for years to come. Among the projects she worked on include the Obama Presidential Center, Wrigley Field expansion, Wilson Yard, Edens Collection, and South Loop redevelopment. Each project that passed by her desk benefited greatly from her ideas and contributions; and

WHEREAS, As a valued leader, her hard work and diligence serve as an inspiration to us all. Patti has earned the respect not only of her colleagues and those working under her direction, but also from

members of the City Council; and
