### ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-1 Community Shopping District symbols and indications as shown on Map No. <sup>7-1</sup> in the area bounded by

West Belmont Avenue; a line 150 feet east of and parallel to North Albany Avenue; the public alley next south of and parallel to West Belmont Avenue; and a line 100 feet east of and parallel to North Albany Avenue;

to those of a B2-2 Neighborhood Mixed-Use District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
